


She was glad that she picked a few pebbles up... Though, She also was very sad that she didn't pick up more.



The manual is not only intended to help in preparation for the Title Insurance Test, it also serves as a valuable reference and resource for the rigors and everyday challenges of the practice of title insurance professionals.

The Young Title Person Committee is currently seeking nominations for its selection of the Young Title Person and Young Title Professional.

The Purpose of the Young Title Person Program is to:

- Recognize the achievements of outstanding Young Title People (YTP)
- Aid in the recruitment and retention of dedicated young persons to the title industry
- Provide opportunities of YTP to become more familiar with KLTA and its members
- Encourage the involvement of YTP in the assocition

The two persons chosen for the Young Title Person and Young Title Professional Awards each year will receive special recognition and paid registration to the Kansas Land Title Association Annual Convention.

The nomination form, which is to be completed by an owner, manager or supervisor of a KLTA Member firm and submitted to the Committee Chair by July 15, 2020. The nomination form should be mailed as soon as possible. Your nominee **may** then be contacted and asked to fill out a questionnaire.

The Young Title Person Committee <u>may</u> set up interviews with each nominee. The committee will select the winners, if any, of the Young Title Person/Professional Awards for the year 2020 and will present the awards at the Annual Convention to be in August.

THE YOUNG TITLE PERSON OF THE YEAR AWARD is presented to the person nominated and selected by the Committee for his or her dedication to the title industry and growing leadership potential.

Anyone, age 35 or younger, employed in the land title industry by a member of the Kansas Land Title Association, is eligible to be nominated for the Young Title Person Award.

THE YOUNG TITLE PROFESSIONAL OF THE YEAR AWARD is presented to the person nominated and selected by the Committee for his or her dedication to the title industry and who is actively involved in management as an employee. Anyone, age 35 or younger, employed in a management position in the land title industry by a member of the Kansas Land Title Association, is eligible to be

Veto Session?

The Kansas Legislature was scheduled to return to wrap up the 2020 session yesterday, April 27th. That plan was scuttled last week when the Legislative Coordinating Council postponed the restart due to COVID-19 concerns. The new plan is to revisit the idea of returning before May 3rd which would be a day before Gov. Kelly

could lift the statewide "stayat home" order. The complication is that local governments have the power to continue or extend "stayat-home" orders. While the Kansas Legislature is exempt from this "stay at home" order, the optics would be less than ideal, given that a majority of legislators fall within the "At-Risk" group. Nevertheless, there is a strong push by a group of legislators to start the reopening process. This group, 80 plus strong and all Republican, want a plan from the governor. House Majority Leader Dan Haw-

kins posted the letter with signers on his Facebook page this past week. Should the "stay-at-home" order be rescinded, it would be difficult for these legislators to avoid returning to Topeka after taking such a hardline stance on reopening the economy. If the Veto Session resumes—and that is still an "if" at this point—the legislature could discuss the State revenue shortfalls, Executive Order reform and possibly Medicaid Expansion. However, none of these items are on any agenda currently, and with just eight bills passed so far this session, it is unlikely

we will see a flurry of bills headed to the governor during veto.

The Kansas Legislative Research Department has released its 2020 legislative summary of bills passed. This is the shortest initial summary in my 12 years with the KBA. It is only 12 items deep, with four of those items being executive order- or concurrent resolution-related. Of the eight bills signed into law, two dealt directly with COVID-19 actions. The only major bills to pass were the state budget (SB 66) and the transportation plan (House Sub for SB 173). Other bills are primed for passage, but that depends on the actions taken during veto.
